Products to which is referring this declaration, are meeting **global migration limits** according to Regulation 10/2011, in following testing conditions, and are compliant with test results.

4. Adequate information on substances subject to restriction in food, obtained by experimental data or theoretical calculation about the level of their specific migration and - where appropriate - purity criteria in accordance with Directives 2008/60/EC, 95/45/EC and 2008/84/EC to enable the user of these materials and articles comply with the relevant EU rules or - in their absence - national provisions applicable to food:

No dual use additives substances were used for the production of the products to which this declaration refers to.



Products meet the requirements of Directive 94/62 on packaging and packaging waste and heavy metal content and another amending directive. The sum of the concentrations of lead (Pb), cadmium (Cd), mercury (Hg) and hexavalent chromium (Cr VI) does not exceed 100 mg/kg.

No primary aromatic amines listed in Annex II of Regulation (EU) No 10/2011.

- 5. Requirements to use of material or product:
 - Products made of OPS foil are intended to come into contact with any type of food,
 - The products are intended for long-term storage at room temperature or below, including heating to 70 ° C for no longer than 2 hours.
 - The contact surface / volume simulant 6 dm²/kg of food.
- 6. If a multi-layer material or article functional barrier is used confirmation that the material or article complies with the requirements of Art. 13 paragraph. 2, 3 and 4 or art. 14 paragraph. 2 and 3 of this Regulation:

The declaration was issued on the basis of test results and based on the declarations of producers of raw materials and other materials used for production.

According to Article 15 Section 3 Commission Regulation (EC) No 10/2011 "The written declaration shall permit an easy identification of the materials, articles or products from intermediate stages of manufacture or substances for which it is issued. It shall be renewed when substantial changes in the composition or production occur that bring about changes in the migration from the materials or articles or when new scientific data becomes available."

This declaration is valid for the products delivered by silver plastics® as specified above. The Regulation (EU) No 10/2011 (replaces directives 82/711/EEC and 85/572/EEC) provide a guideline for the selection of test conditions to be used for various food products.

According to that and under consideration of the food contact conditions stated, the product complies with the stipulations of these Directives regarding the packaging of food to be packed. The user shall verify himself that the product is suitable for the intended food to be packed beyond the stipulations of the Directives.

In particular it is emphasized, that in case of printed material, no contact is allowed between the printing ink and the food product.
